JUSTIFICATION:

This change a credit from the contractor for excessive overtime for steel inspection. The District is taking this credit because of delays, caused by the steel fabricator, made it necessary to work multiple shifts and at multiple sites in order to meet the contractor's accelerated schedule. Inspection fees were based on contractor's original schedule and did not anticipate excessive overtime or multiple fabrication sites.
