An advance of funds may be obtained to cover such expenses, with the advance to be repaid or adjusted upon the filing of a regular claim for the actual expenses incurred.

THAT members of the Board of Education - HOWARD GOLDSTEIN, LISA KORBATOV, NOAH MARGO, ISABEL HACKER, MEL SPITZ and MICHAEL BREGY, Superintendent of Schools, may collectively, and the named persons are hereby directed for the period beginning December 5, 2017, through December 4, 2018, and unless and until otherwise directed by this Board, to travel throughout the United States to attend conferences concerned with educational and/or financial matters, educational legislation, or with Federal appropriations to schools, or to visit schools for the discussion or observation of any school matter appertaining to the duties of the named persons or any question of interest to the school district. An advance of funds may be obtained to cover such expenses, with the advance to be repaid or adjusted upon the filing of a regular claim for the actual expenses incurred.

THAT the Governing Board of the Beverly Hills Unified School District hereby delegates to the Superintendent of Schools, MICHAEL BREGY, authority to authorize travel by the Superintendent, LA TANYA KIRK-CARTER, Assistant Superintendent Business Services, DUSTIN SEEMANN, Assistant Superintendent Education Services, LAURA CHISM, Assistant Superintendent Student Services and LUKE PAVONE, Executive Director Human Resources for the period beginning December 5, 2017, through December 4, 2018, and unless and until otherwise directed by the Board, to attend meetings within the State of California called by the State Superintendent of Public Instruction, the State Board of Education, regular or interim committees of the California legislature; to attend meetings of the State legislature, or to discuss school district business with representatives of the United States; or to attend within the State meetings of any society, association, or organization for which the school district has subscribed for membership, or any convention held in connection therewith or to attend councils or commissions of the State of California for the discussion or observation of any school matter appertaining to the duties of the employee or any questions of interest to the school district or to attend within the State any meetings relating to public school matters. An advance of funds may be obtained to cover such expenses, with the advance to be repaid or adjusted upon the filing of a regular claim for the actual expenses incurred.

THAT the Governing Board of the Beverly Hills Unified School District hereby delegates to the Superintendent of Schools, MICHAEL BREGY, authority to authorize travel by the Superintendent, LA TANYA KIRK-CARTER, Assistant Superintendent Business Services, DUSTIN SEEMANN, Assistant Superintendent Education Services, LAURA CHISM, Assistant Superintendent Student Services and LUKE PAVONE, Executive Director Human Resources for the period beginning December 5, 2017, through December 4, 2018, and unless and until otherwise directed by this Board, to travel throughout the United States to attend conferences concerned with educational and/or financial matters, educational legislation, or with Federal appropriations to schools, or to visit schools for the discussion or observation of any question of interest to the school district. An advance of funds may be obtained to cover such expenses, with the advance to be repaid or adjusted upon the filing of a regular claim for the actual expenses incurred.

THAT authorization be given to MICHAEL BREGY, DUSTIN SEEMANN, LA TANYA KIRK-CARTER, LAURA CHISM, LUKE PAVONE and ANGELI VILLAFLORE to purchase and sign for items acquired from purchase through State Agency for Surplus Property.

THAT authorization be given for one of the following to sign Board approved Collection Reports to County Superintendent of Schools Office:, MICHAEL BREGY, DUSTIN SEEMANN, LA TANYA KIRK-CARTER, LAURA CHISM and LUKE PAVONE..

THAT authorization be given for the following to sign Board approved budget transfers: MICHAEL BREGY, DUSTIN SEEMANN, LA TANYA KIRK-CARTER, LAURA CHISM and LUKE PAVONE.

THAT authorization be given for one of the following to accept resignations on behalf of the Board of Education and to certify the effective date as the date of receipt: MICHAEL BREGY, DUSTIN SEEMANN, LA TANYA KIRK-CARTER, LAURA CHISM and LUKE PAVONE.

THAT authorization be given for all volunteers in the District, who have been recognized by the administrative staff, be included in the District's Workers' Compensation coverage.

THAT the second (2nd) and fourth (4th) Tuesday of each month be designated for regular Board meetings. The Board of Education reserves the right to change the meeting schedule as necessary.
