EMERGENCY RESOLUTION – PUBLIC PROJECT

Health and Safety of Students and Staff at Beverly Hills High School, Paging System

On Motion of Member _____, seconded by Member _____,
the following resolution is adopted by the Governing Board of the Beverly Hills Unified School
District:

WHEREAS, an emergency has arisen at Beverly Hills High School following an assessment by
District Staff; and

WHEREAS, the Public Paging System was identified as non-functioning for use during
emergency situations and/or communicating public safety announcements; and

WHEREAS, the District must address the situation as an immediate health and safety concern
for the continuation of classes and/or to avoid danger to life or property; AND

WHEREAS, Public Contract Code Section 20113 (school districts) provides that public
agencies may, with the unanimous approval of the governing board and approval of the county
superintendent of schools, contract for the performance of labor and purchase of materials
without advertising for or inviting bids in an emergency when such work is necessary to permit
the continuance of existing school classes or to avoid danger to life and property;

THEREFORE, BE IT HEREBY RESOLVED, That the Governing Board of the Beverly Hills
Unified School District has determined that these circumstances constitute an emergency
condition and request approval from the county superintendent of schools to enter the contract
for:

The cost for services for \$116,602.23. The scope includes installation of category cabling into
existing conduit, installation of new paging speakers, programming and configuration, and final
system testing.

Without advertising or inviting bids pursuant to Public Contract Code Section 20113.
