

**BEVERLY HILLS UNIFIED SCHOOL DISTRICT
AMENDMENT NO. 1 TO**

AGREEMENT FOR VENDOR SERVICES

Amendment No. 1 is made and entered into this 27th day of November, 2018, by and between the **BEVERLY HILLS UNIFIED SCHOOL DISTRICT**, (hereinafter referred to as the "DISTRICT"), and **GEO-INSTRUMENTS** (hereinafter referred to as "VENDOR") pursuant to the Board of Education's approval of additional services on November 26, 2018, for extending the Vendor's services to an additional 12 months for rental and installation of monitoring equipment (for vibration, sound, and particles) and cloud-based footage/data access at the DISTRICT's Beverly Hills High School (hereinafter referred to as "PROJECT") as more fully described below.

RECITALS

WHEREAS, on or about June 26, 2018, the DISTRICT and VENDOR entered into an Agreement for Vendor Services (the "Agreement"); and

WHEREAS, the Agreement permits the DISTRICT and VENDOR to amend the Agreement, upon the mutual written agreement of the parties; and

WHEREAS, the DISTRICT and CONTRACTOR now desire to amend the Agreement to increase the scope of work for the PROJECT as set forth below.

NOW, THEREFORE, for good and valuable consideration of the mutual promises and covenants contained herein, the receipt and sufficiency of which is hereby acknowledged, the parties hereto agree as follows:

I. Scope of Services

- a. Provide services for an additional twelve (12) months, from January 2018 through December 2018, as described on attached Exhibit "A" (vendor proposal).

II. Compensation:

- a. A fee to be in a not-to-exceed amount of **SEVENTY FOUR THOUSAND TWO HUNDRED SEVENTY EIGHT AND 80/100 DOLLARS (\$74,278.80)**

1. This Amendment, upon execution, constitutes a supplemental work authorization from the District as described below and agreed to by the Parties.
2. This Amendment No. 1 shall be effective ONLY upon execution by both the District and Vendor.
3. This Amendment No. 1 may be executed in duplicate originals, each of which is deemed to be an original, but when taken together shall constitute one and the same instrument.

4. This Amendment No. 1 shall affect only the items specifically set forth herein, and all other terms and conditions of the Agreement shall remain in full force and effect.

IN WITNESS WHEREOF, the Parties hereto have, by their duly authorized representatives, executed this Amendment No. 1 to the Agreement for Vendor Services, as of the day and year first above written.
