Memorandum of Understanding

The Riverside Unified School District Board of Education accepted our recommendation to renew the award to Sunrise Produce for the 2020-21 school year. This is a **Memorandum of Understanding (MOU)** whereby the vendor will need to provide the following required documents in order to renew the existing proposal.

Complete and sign this Memorandum of Understanding and return in the enclosed envelope to Adleit Asi by May 1, 2020.

By signing this agreement, the Vendor agrees to the following:

All specifications, terms and conditions of proposal No. 2017/18-11 are included with full force and like effect as if fully rewritten herein.

An updated certificate of insurance to include Riverside Unified School District Nutrition Services as part of your Comprehensive General Liability Insurance, Comprehensive Automobile Liability and Workers Compensation Insurance is required no later than July 1, 2020.

Any price adjustments must be at or below the consumer price increase index for “All Urban Consumers” Database Series for the statistical area of “US City Average” from the category “Food Away From Home” as listed on the Bureau of Labor Statistics (BLS) website (<http://www.bls.gov/data/>). The Vendor may use the preceding twelve (12) months. Vendor may provide alternate documentation if BLS is not available. Acceptance of alternate documentation is at the discretion of the Director of Nutrition Services.

Price list must be received no later than May 30th and will be effective the new school year July 1st. Orders placed and delivered prior to July 1st shall inherit the previous school year approved price.

A list of delivery locations, days of delivery, and delivery window times is requested for the new school year.

I agree to the above requirements. I understand that failure to comply with any of the above requirements may result in disallowance from participating in the multi-year extension agreement.
