FLAT RATE FEE SCHEDULE FOR INDEPENDENT EDUCATIONAL EVALUATIONS*

A. Comprehensive Neuro-Ed or Psycho-Ed Evaluations – Parent Initiated

Parent Initiated Comprehensive Neuro-Ed or Psycho-Ed IEEs------\$5,000 flat rate*

Parent Initiated IEEs are the traditional IEEs when a district psycho-educational evaluation has been completed and the results have been shared at a meeting. The parent requests the IEE as a second opinion evaluation. Dr. Veronica will complete a comprehensive evaluation that will include IQ (except when adhering to Larry P.), academics, psychological domains, and social-emotional functioning including adaptive skills. Dr. Veronica shall also evaluate for ADHD if that is in question.

B. Referral Targeted Neuro-Ed Evaluations – District Initiated

District Initiated Neuro-Ed IEE to address a specific referral question ------ \$3,000 flat rate*

District Initiated IEEs are requested when the student is undergoing a district psycho-educational evaluation and there is question as to ADHD and OHI eligibility; this type of IEE is applicable when district does not have the appropriate/qualified examiner to complete this type of evaluation (i.e., does this student have ADHD and does the student require an IEP based on OHI eligibility).

In an effort to optimize legal compliance, districts are beginning to understand that ADHD is a neurodevelopmental disorder most appropriately diagnosed by a clinical psychologist, particularly a neuropsychologist, and not a pediatrician or a primary care physician.

These types of IEEs will consist of evaluation and assessment of symptoms of ADHD (i.e., attention, hyperactivity, impulsivity, working memory, and executive functioning skills) via parent, teacher, student (rating scales and direct testing) as well as observation of the student in his/her educational environment.

C. The following IEEs are offered at a <u>flat rate</u> of \$2,500* whether Bilingual, Spanish, or English

- ➤ Educationally-Related Mental Health Services (ERMHS) Evaluations
- > Transition Plan Evaluations
- > Observation Reports (intended to answer referral questions as to whether the current program appears appropriate for the student and/or whether mainstreaming opportunities are recommended at the present time.)
- *--Please note that evaluations are accepted so long as there is no waiting list AND the student's school is within 45-miles of the Riverside office location. When a waiting list is implemented, it will notify you on the website and voice message. Any case beyond a 45-mile radius is considered on a case by case basis (a \$500 travel fee is applied to the cost of the evaluation). - --Flat rate indicates that the evaluation is comprehensive and includes everything from A to Z including travel expenses within a 45-mile radius for the school observation(s) and attendance at the meeting to review the IEE. No additional charge is implemented for Bilingual/Spanish IEEs.
