

SERVICE AGREEMENT

Between

Alvord Unified School District

and

The Silicon Valley Mathematics Initiative, LLC

This document is to serve as an Agreement between Alvord Unified School District and the Silicon Valley Mathematics Initiative, LLC (SVMI). The effective date of this Agreement shall be July 1, 2020 and extended through June 30, 2021.

1. Service Deliverables

The Silicon Valley Mathematics Initiative will provide professional development services and resources as the benefits of membership in SVMI. Alvord Unified Shores School District agrees to pay a flat fee of \$6,300 for membership during the 2020-2021 school year.

2. Funding and Payment

SVMI, LLC shall invoice Alvord Unified School District beginning July 1, 2020 for district membership in accordance with *Exhibit A: Benefits of SVMI Membership* attached hereto and incorporated by reference herein expressly made part of this agreement. Belmont Redwood Shores School District shall reimburse SVMI, LLC an amount not to exceed a maximum amount of \$6,300.00.

3. Indemnification

Alvord Unified School District and SVMI, LLC mutually agree to indemnify and to hold harmless the other party from damage to persons or property resulting from any act or omission on the part of each party, its employees, agents or officers.

4. Termination

Either Alvord Unified School District or SVMI may terminate this Agreement by giving thirty (30) days written notice to the other party. Alvord Unified School District shall reimburse SVMI for acceptable and allowable work performed under this Contract, and for all non-cancelable obligations made in connection with such work, through the date of termination. All related data that has been transferred shall be destroyed, deleted, or otherwise removed from SVMI computers and servers.

5. Entire Agreement

This Consulting Agreement and the Attachment hereto constitutes the entire agreement of the parties concerning the services described herein.

6. Data Security

All applicable Federal and State data and information security compliance Acts (such as FERPA, HIPPA, CIPA, etc.) will be followed, as applicable, when sharing and transferring data between parties with emphasis on data security. Information will be transferred from the district using secure methods agreed upon by both parties. SVMI shall store the data in a way that is physically and electronically secure in order to safeguard the data from unauthorized access.

7. No Release of Personally Identifiable Information.

No personally identifiable information or other confidential information within the Data may be released to any third party other than authorized representatives, including contractors of the SVMI, who require the information in order to assist SVMI in conducting the Study and who are under confidentiality obligations no less restrictive as those set forth herein. In the event of an unauthorized release of confidential information by SVMI, SVMI agrees to promptly notify the District in writing and to provide prompt assistance as reasonably requested by the District with respect to fulfilling any data security breach obligations required of District and set forth in applicable law.

8. Legal Obligations

The parties acknowledge that the Data transferred under this Agreement may contain confidential information, which is protected from disclosure under applicable law. SVMI and District each agree to comply with all applicable laws with respect to its use and handling of the Data. District agrees that it has all necessary rights and licenses necessary to provide Data to SVMI for purposes of and in accordance with the terms of this Agreement. SVMI agrees that it will (a) instruct persons with access to confidential information about the requirements for handling confidential information, (b) notify such persons of the sanctions against unauthorized disclosure or use of confidential information, and (c) ensure that all such persons agree in writing to restrictions and conditions no less rigorous than those that apply to SVMI in this Agreement with respect to such information.



Benefits of being a Member District **Professional Learning Sessions and Services**

- Participation in Virtual Summer Coaching Institute July 27, 2020 – July 31, 2020. The focus of the institute is to support teachers in designing and teaching student-centered interactive lessons to improve student learning in a virtual setting. The summer institute will target four grade level spans: P-2, 3-5, 6-8 and High School. Member institution may send teachers to the 5-day summer institute as part of the 2020-2021 membership at no additional cost.
- Participation in the Math Network Meetings for all math coaches and leaders. These sessions will be offered as distance learning sessions and when shelter-in-place orders are lifted these will be also offered in central locations as face-to-face meeting.
- Participation in SVMI Professional Learning Sessions for teachers and coaches. SVMI will facilitate five sessions (Sep., Oct., Nov., Jan., and Feb.). These sessions will be offered as distance learning workshops and when shelter-in-place orders are lifted these will be also offered at multiple locations in the northern California.
- Participation in the Principal as Instructional Leaders series open to all administrators and coaches (twice a school year). These sessions will be offered as virtually and when shelter-in-place orders are lifted these will be also offered at a central location.
- Access to the SVMI Lesson Study Project and opportunity to apply for Research Lesson Mini-Grants for teams of teachers. (\$2,500/team).
