**AGREEMENT FOR CARES ACT FUNDING SUPPORTING THE “ALL FOR ONE” CAMPAIGN**

This Agreement is entered into by and between, **Riverside County Office of Education Foundation**, hereinafter referred to as “FOUNDATION”, and **Alvord Unified School District**, hereinafter referred to as “DISTRICT”, each being a “Party” and collectively the “Parties”.

**RECITALS**

FOUNDATION has received an allocation of CARES Act funding from the County of Riverside Board of Supervisors to support the “All for One” Campaign, which aims to provide computer devices and hotspots to students throughout Riverside County to bridge the local digital divide. This funding will be passed through to school districts in Riverside County to allow those districts to purchase computer devices and Wi-Fi hot spots to facilitate access to online learning and educational support services.

**AGREEMENTS**

1. **TERM:** The term of this Agreement shall be from **September 10, 2020 to November 30, 2020**.
2. **SERVICES:** DISTRICT agrees to:
  - A. Participate in FOUNDATION’S “All for One” campaign by procuring digital devices (iPads, Chromebooks, etc.) and Wi-Fi hot spots for DISTRICT students.
  - B. Adhere to all applicable terms of the original agreement between the FOUNDATION and the County of Riverside, including but not limited to Uniform Administrative Requirements, Cost Principles, and Audit Requirements for Federal Awards (2 CFR Part 200) and maintain necessary documentation in all actions associated with these funds. A copy of said agreement is available by emailing [purchasing@rcoe.us](mailto:purchasing@rcoe.us).
  - C. Submit proof of purchase documents (purchase orders, invoices, receipts) along with **Exhibit A, CARES Act Expense Summary** by **11/20/2020** to Riverside County Superintendent of Schools, Attention: **Accounts Payable**, P.O. Box 868, Riverside, California 92502 or via email to [accountspayable@rcoe.us](mailto:accountspayable@rcoe.us).
3. **PAYMENT:**
  - A. For and in consideration of the services rendered, FOUNDATION agrees to pay DISTRICT **\$730,000.00** for purchase of approximately **2000 devices** and **200 hot spots**.
  - B. In no event shall the total payment(s) made under this Agreement exceed the sum of **\$730,000.00** without a written authorization from FOUNDATION.
  - C. In the event DISTRICT receives payment for services under this Agreement which is later disallowed by FOUNDATION due to DISTRICT’S nonconformance with the terms and conditions herein, DISTRICT shall promptly, upon request, refund the disallowed amount to FOUNDATION.
4. **MUTUAL HOLD HARMLESS:** The Parties hereto, and each of them, do hereby mutually agree to indemnify, defend, save and hold harmless each other, and their respective officers, agents and employees, of and from any and all liability, claims demands, debts, suits, actions and causes of action, including wrongful death and reasonable attorney’s fees for the defense thereof, arising out of or in any manner connected with the performance of any act or deed under or pursuant to the terms and provisions of this Agreement by such indemnifying Party, or its officers, agents and employees.

5. **ENTIRE AGREEMENT:** This Agreement, including any attachments, exhibits, or documents incorporated herein, constitutes the entire understanding and agreement between Parties hereto with respect to the subject matter hereof and no prior or contemporaneous agreements of any kind or nature relating to the same shall be deemed to be merged herein.
