



2021-2022 School Portraiture Contract

Agreement made this 26th day of April 2021, between Myra Linn Elementary School (10435 Branigan Way • Riverside, CA • 92505) hereinafter referred to as the “Client”, and Studio 1 (9060 Rancho Park Court • Rancho Cucamonga, CA • 91730) with respect to school portraiture and associated services.

Section 1 – Services

1. Studio 1 agrees to provide portrait services to the client which includes:
 - a. Fall pre-pay portraiture including all students and staff regardless if a purchase is completed
 - b. Spring pre-pay portraiture
 - c. Panoramic / Promotion Pictures

Section 2 - Time of Performance

1. Studio 1 agrees that individual portraits will be shipped to the client 2-3 weeks after the date of the event. Shipment will be made via FedEx or at the discretion of Studio 1.

Section 3 – Yearbook Incentive

1. Studio 1 agrees to supply the client with a 48 page soft cover, color yearbook, up to but not surpassing 1 per student in the school for the first year of service (2021-2022 school year). Fall and spring portraits must be completed for the yearbook incentive to apply. Any additional pages will be billed at a price of 20 cents per page, per book. Client will be responsible only for the difference in pricing between the 48 page color yearbook (based upon the final amount of yearbooks printed) and the final yearbook produced with the upgrades applied. Sales tax will apply to the cost of all yearbooks produced.

Section 4 - Length of Contract

1. This agreement shall be for a minimum initial period of 1 year from the said date provided within this contract.

Section 5 - Exclusive Rights

1. Studio 1 shall be the exclusive photographer for all fee-based portraiture at the client's location

Section 6 – Supply and Distribution of Sales Materials
