NOW THEREFORE, in consideration of the mutual covenants and promises set forth herein, the parties agree as follows:

Attendance Numbers

The maximum number of students allowed is **30 students per each session for a total of 90**. The Group can request to alter the student numbers on this agreement up to 30 days before their online field trip. The Group is responsible for 100% of guaranteed minimum attendance. The fee is inclusive of program materials, postage to school site, and staffing. Pathfinder Ranch must approve all amendments to these numbers by the listed deadline.

Group Responsibility

The Group agrees to be responsible for and to attend to the supervision and conduct of all its attendees.

Loss of or Damage to Personal Property

Pathfinder Ranch is not responsible for the loss of or damage to personal items of the Group's members.

Staffed Programming

Pathfinder Ranch instructors and staff are not responsible for the supervision or behavior management of attending Group members. The Group understands that not attending or being tardy to activities will impact their trip, and that activities cannot be rescheduled.

Indemnify and Hold Harmless

The Group acknowledges that the use of Pathfinder Ranch's facilities and participation in Pathfinder Ranch's activities involve certain inherent risks of property damage and/or personal injury, including death. The Group acknowledges that it understands the risks as well as the policies, rules and regulations implemented by Pathfinder Ranch to minimize such risks.

The Group hereby agrees to defend, indemnify and hold harmless Pathfinder Ranch, its affiliates and subsidiaries, employees, agents, volunteers, officers, directors, board members and their immediate families, successors and assigns against any loss, damage or injury associated with the Group's participation in and use of Pathfinder Ranch's activities and facilities.

Furthermore, the Group agrees to release, discharge and not to initiate or be a party to any legal action or administrative claim against Pathfinder Ranch, its officers, directors, employees, agents, partners, shareholders, volunteers and board members arising out of the Group's participation in and use of Pathfinder Ranch's activities and facilities.

Right of Refusal

The group understands that Pathfinder Ranch reserves the right of refusal of its services and resources to any group or individual(s) that cannot reasonably comply with the responsibility requirements or which displays behavior which Pathfinder Ranch, in its sole discretion, determines to be unreasonable or unsatisfactory.
