IMPORTANT: This Contract for a Group Sales Event ("Event") is not valid until executed both parties; supersedes any prior agreements between Knott's Berry Farm ("Park") and Consignee Group; and once valid may only be modified or canceled by mutual written agreement. Complete Terms & Conditions applicable to this Contract are provided separately and by signing below, Consignee group acknowledges both their receipt and acceptance of all Terms and Conditions associated with this Contract.

### Terms & Conditions - Catered Event

**PLEASE READ THE ENTIRE CONTACT. Agreement of Consignee Group to all terms and conditions listed in this contract ("Contract") is indicated by the signature below and/or on page one of this Event Contract. This contract becomes effective only after (i) a signed copy has been received by Knott's Berry Farm ("Park"); (ii) acceptance by Park management; (iii) it is signed by Park management; and (iv) the fully executed document is returned to Consignee and Park in accordance with its terms and conditions.**

1. Consignee Group acknowledges that upon receipt of Knott's Berry Farm ticket, Consignee Group agrees to pay for tickets redeemed or guaranteed, whichever is higher.
2. Price quoted for admission is determined by group size and event date. If actual attendance falls below guarantee, pricing may be adjusted.
3. Consignee group can destroy any unused tickets after the event date. Tickets are not to be sent back to the park.
4. Group will be invoiced within 14 days of the event date for Ticket and Meal guarantee, or actual number of guests in attendance at the catered event or tickets redeemed at the gate, whichever is higher. In addition, drink wristbands will be charged based on the amount ordered. All food, beverage, drink wristbands, bottle vouchers and artist services are subject to applicable taxes.
5. Remit payment to: Knott's Berry Farm, Attn: Accounting, 8039 Beach Blvd, Buena Park, CA 90620.
6. Final count guarantees are due seven (7) business days prior to the Event and billing will be determined based upon the final count guarantee.
7. Cancellation fees apply. Sixty (60) days or more from date of Event: 25% of calculated catering and ticket revenues; within 30-59 days: 50% of calculated catering and ticket revenues; within 7-29 days: 75% of calculated catering and ticket revenues; within 7 days: 90% of calculated catering and ticket revenues. Catering and ticket revenues based on ticket order, meal estimate and catering menu selected. Group must guarantee a minimum of 50 catering meals and tickets to book a catered event.
8. A non-refundable deposit of \$1,000.00 is required to secure space for the Event.
9. To reserve a private area in Knott's Berry Farm's catering area, "Consignee Group" must sign this agreement by the date indicated. After this date, if the "Consignee Group" has not made a final determination, they will be placed on a first option basis and Knott's Berry Farm will contact the "Consignee Group" before space is released to another.
10. Knott's Berry Farm reserves the right to reassign catering based on final meal guarantee.
11. To qualify for an Event, customer must guarantee a minimum number of meals and admissions ("Minimum Guarantee"), as required in writing by Park. Customer's final bill is based on 100% of the Minimum Guarantee or the actual quantity served, whichever is higher. By signing below, the "Contact Person" acknowledges this statement and agrees to these terms.
12. Park cannot ensure Consignee Group will be served if it exceeds, makes changes to, or fails to provide the Minimum Guarantee by the specified deadline. Final service location is determined by the Minimum Guarantee and menu selection. The Minimum Guarantee of meals and admissions is as noted on page one of this Contract. Menu selections may be limited based on available service areas or size of group.
13. All Events are rain or shine. No rain checks or refunds.
14. All ticket order and reorders must be placed in writing and are subject to Park's approval. Reorder approval based on payment of initial order. Park reserves the right to require payment prior to ticket shipment and/or to complete credit inquiries as necessary.
15. Consignee group assumes full responsibility for all admissions and/or parking tickets issued, including tickets that may be misplaced, lost and/or stolen then redeemed.
16. A finance charge of 1.5% per month (18% per annum) is applied to any unpaid balance after payment due date. A fee of \$25.00 and other related charges are assessed for each returned check.
17. Park's various Group Sales plans are independent of each other. Tickets issued and sold through one plan cannot be applied or combined with any other of Park's Group Sales plans. Park reserves the right to discontinue programs and collect

and unsold tickets and funds due.

18. Consignee Group agrees that tickets issued under any Group outing program are available for sale only to Consignee Group's employees, members and/or guests, and not to the general public. Tickets are not to be resold to other companies or individuals. Participating guests may obtain group outing tickets from the Consignee Group only, not from the Park. Tickets will not be available at the front gate unless Consignee Group makes arrangements to distribute the tickets personally.

19. Prices, hours, dates, and attraction availability are subject to change without notice. Price schedules become final on the day of Contract approval. Park reserves the right to be closed to the public and Season Pass holders for private Events, capacity limitations, and other reasons. Certain attractions and/or Park facilities may be closed due to inclement weather, extreme temperatures, maintenance, and/or other reasons.

20. The legal drinking age at Park is 21 years of age without exception. A valid driver's license or state ID is required from each person obtaining an alcoholic beverage. Alcoholic beverages at catered Events may be served during food service time only. Park reserves the right to limit the amount of beer or alcoholic beverages ordered and/or served for any catered outing.

21. Food or beverages may not be brought into or taken out of any group function at Park. All-You-Can-Eat catered meals, if available, allow unlimited visits to the food line during the meal service time only. Any leftover food at the end of meal service is the property of Park. Baskets, coolers, or any type of personal picnic items or belongings are not permitted inside Park.

22. Park reserves the right to review and refuse any handouts, "giveaways", entertainment, decorations, banners, or other signs on Park property by an group.

23. Purchase orders, if issued by Consignee Group in connection with this Contract, are not accepted and shall not modify this Contract.

24. This Contract does not constitute and shall not be construed as constituting a partnership or joint venture between or among Consignee Group and Park. No party shall have any right to obligate or bind any other party in any matter whatsoever, and nothing herein contained shall give, or is intended to give, any rights of any kind to any third persons. Park has no responsibility or liability whatsoever in connection with the management and operation of Consignee Group's business. Consignee Group will have entire charge of the management and operation of Consignee Group's business and Park will, in no event, be responsible for acts or omissions of Consignee Group or Consignee Group's employees.

25. This Contract shall be legally binding upon and shall inure to the benefit of the parties hereto, their respective successors and permitted assigns. Neither party hereto may assign this Contract not any rights or obligations set forth herein, in whole or in part, without the prior written consent of the other party. Notwithstanding the foregoing Park may assist this Contract to an affiliate or division so long as Cedar Fair L.P. exercises management control over or owns a controlling interest in or is under common control with such affiliate or division.

26. This Contract is governed by, and is to be construed in accordance with, the laws of the state in which Park is located. Consignee Group hereby irrevocably submits to the exclusive jurisdiction of a state or federal court of competent jurisdiction in the state in which Park is located for the purposes of any action arising out of this Contract and, in the event that it does not already have a registered agent in the state, irrevocably appoints the Secretary of State or other such similar officer of the state as its agent for service of process. Consignee Group shall be responsible for all costs including attorney's fees that me incurred as a result of its failure to make timely payment.

27. This Contract is subject to acceptance by Park general manager or his/her designee. Agreement of Consignee Group to all foregoing terms and conditions is indicated by signature below. The person signing this Contract warrants he/she is authorized to sign it on behalf of the Consignee Group. The signer of this Contract does, by execution of this Contract, bind the Consignee Group and its owners for full performance hereunder including payments of all amounts due pursuant to this Contract.
