

## **RELEASE AND WAIVER OF LIABILITY AND INDEMNITY AGREEMENT**

IN CONSIDERATION of the foregoing lease, LESSEE acknowledges and agrees for himself, herself, itself and any Personal Representatives, heirs and next of kin that he, she or it assumes full responsibility for the safe use and operation of the PROPERTY leases herein during the entire time that the PROPERTY is under LESSEE'S care, custody of control. LESSEE warrants and represents that he, she or it will, at all times, supervise the safe use and operation of the PROPERTY leased herein. LESSEE further agrees that he/she/it is responsible for the full value of the PROPERTY leased herein in the event the PROPERTY is lost, stolen or damaged while in LESSEE'S care, custody or control. LESSOR makes no warranties or representations, express or implied, about the safety of any or the PROPERTY leased.

### **IN FURTHER CONSIDERATION OF THIS LEASE: RELEASE**

LESSEE HEREBY RELEASES, WAIVES, AND DISCHARGES LESSOR, including its agents, servants, employees, officers, directors and shareholders, from and against any and all claims for damages suffered by any person or entity connected with the use or operation of any of the PROPERTY leased herein. This release is intended to include, But is not limited to, liability due to LESSOR'S negligence, regardless of whether such negligence is active or passive. This release is intended to discharge LESSOR from all liability for any injury to any and all person(s) and any and all property connected with the lease of the PROPERTY specified herein. This includes, but is not limited to, PROPERTY damage, loss of the use of PROPERTY, physical injury, death, enjoyment of life, loss of profits, injury to goodwill, injury to reputation, and all other forms of consequential injury and damage, regardless of how such injury or damage is called or characterized.

### **INDEMNIFICATION AND OBLIGATIONS OF LESSEE:**

"Nothing in this agreement shall be construed to mean that Wow Party Rental Inc, assumes any liability of any nature whatsoever arising out of, relating to or in any way connected with the use or operation of the equipment covered by this agreement. Lessee shall be solely responsible for supervising the equipment and for taking such steps including, but not limited to providing attendant personnel, warning signs and other controls necessary to ensure the safe use of the rental equipment.

Lessee shall at all times be solely liable for the use of the equipment. Lessee shall indemnify, protect and save harmless Wow Party Rental Inc, from and against all liabilities, losses and claims of any kind or nature imposed on, incurred by, or asserted against Wow Party Rental Inc, arising out of the concurrent, active or passive negligence of Wow Party Rental Inc, in any way connected with the use of the rental equipment. Lessee hereby waives any and all rights of recovery, arising as a matter of law or otherwise which lessee might now or hereafter have against Wow Party Rental, Inc.

Lessee shall assume the defense of Wow Party Rental Inc, and pay all attorneys fees and costs arising out of any claim for injury by any person in any way related to the lease agreement. Furthermore, Lessee shall pay all attorney fees and cost incurred by Wow Party Rental Inc, necessary to enforce the terms of the indemnity provisions of the lease. "

Lessee further expressly agrees that the foregoing RELEASE, WAIVER AND INDEMNITY AGREEMENT is intended to be as broad and inclusive as is permitted by California law and that if any portion of this agreement is determined to be invalid by a court of competent jurisdiction, then the remainder of this agreement shall remain in full force and effect. This agreement represents the entire agreement of the parties concerning the subject matters above. There are no others. LESSEE understands and agrees that no oral representations or statements have been made by LESSOR to representations set forth herein.

## **RULES FOR USE – CAPACITY**

Safety First! Children's safety depends on presence of adult supervision while any rental equipment is in use. Keep age and size of groups compatible. 15'x15' Jumper holds 10 children from 2-12 years old or 8 children from 9-15 years old, 13'x13' Jumper holds 8 children from 2-12 years old or 6 children from 9-15 years old, 11'x11' Jumper holds 5 children from 2-12 years old or 3 children from 9-15 years old, the Big train holds 17 children from 2-12 years old or 12 children from 9-15 years old.

## **(NO ADULT ALLOWED ON THE INFLATABLE, PLEASE).**

All Slides, Combos, Obstacle courses, holds 3 children from 5-16 years old. Dunk tanks (ages 10 and up) & Velcro Walls (ages 5-15) —1 person at the time. Our Sumo suits, Joust, Boxing Ring, head's off is to be used by two children only! From ages 7 to 16 years old and they must use the helmets provided, our Bungee Run is for two children ages 5 to 16 years old. All food machines must be operated by an adult only!

**SOMERSAULTS, ROUGH HOUSING AND FLIPS ARE NOT ALLOWED. NO SHOES, NO FOOD, NO GUM, NO DRINKS, NO SHARP OBJECTS, NO SILLY STRING ALLOWED**

## **PROBLEMS:**

If Unit begins to deflate, check power cord connections to see if motor has stopped. Make sure outlet has no other appliances plugged in and make sure breaker for the outlet is on. If motor continues to run, check for blockage of air-intake screen on side of motor, Also check both tubes on back of unit for snugness and tighten ties if necessary.

## Damage Waiver

**Lessee can purchase an equipment damage waiver for an additional fee**

**Damage Waiver:** Damage waiver is not insurance. By Lessee acceptance of the Damage waiver on the front of the Lease Agreement and with immediate notification in the event of any accident and the prompt submission of applicable police reports, Wow Party Rental, Inc and Lessee agree that Wow Party Rental, Inc, will waive certain claims against Lessee. The Following Conditions are excluded from coverage under the Damage waive:

- A. Any item of equipment or part thereof which is not returned for whatever reason, including theft;
- B. Loss or damage resulting from improper use, failure to secure during transportation, moving the unit from its original setup place, overloading or exceeding the rated capacity of the equipment;
- C. Loss or damage to motors or other electrical appliances or devices caused by artificial current;
- D. Loss due to mysterious disappearance, wrongful conversion by a person entrusted with the equipment or a shortage disclosed on inventory;
- E. Loss or damage caused by infidelity of Lessee, its employees, or persons to whom the equipment is entrusted;
- F. Loss or damage as a result of vandalism or malicious mischief or intentional abuse.
- G. Loss or damage resulting from misuse, abuse, damage resulting from overturning.
- H. All damage or loss resulting from use of the equipment in violation of any provision of this Lease agreement, violation of any law, ordinance or regulation.
- I. When specifically noted as **damage waiver not purchase** on the front of this Lease agreement.

**“ Lessee grants Lessor’s agents permission to enter the property of the lessee after the rental term has ended to reasonably and peacefully take the rental equipment from the premises occupied by the lessee. Lessee waives the right to any claims to any property right interest in the rental equipment after the term of the lease has ended.”**
