Operational Agreement
Fiscal years 2022/2023, 2023/2024, 2024/2025**

This Operational Agreement stands as evidence that the Riverside Area Rape Crisis Center (RARCC) and the Alvord Unified School District intend to work together toward the mutual goal of providing quality violence prevention programming to students, parents, and faculty. All services provided by the RARCC are free of charge.

The Riverside Area Rape Crisis Center will provide the following presentations per request of the Alvord Unified School District: Child Abuse Prevention, Sexual Harassment Prevention, Teen Dating Violence Prevention, Rape Prevention Education, Bullying/Harassment Prevention, Kid Power- Self- Defense Workshops, and Women2Women Self-Defense. Additionally, the RARCC will provide the following services to persons referred by the Alvord Unified School District: 24-hour crisis intervention, advocacy and accompaniment for survivors and their families; follow-up services; short term counseling; survivor groups; information and referrals.

All presentations are age-appropriate and are tailored to suit the needs of each school. RARCC staff are available to meet with the school district and/ or individual school staff to preview materials/ handouts and adjust the presentation to appropriately accommodate the needs of the students.

The two agencies agree to a reciprocal exchange of personnel for volunteer and staff training, or other projects where specific expertise would enhance program effectiveness. The agencies will work together, and a designated staff person will meet quarterly during the school year with Alvord School District staff to discuss common issues, clarify working relationships, and identify any other specific service coordination activities that could offer increased benefit to our mutual clients.

This Operational Agreement is not a commitment to provide funding to Alvord Unified School District or any other entity involved. This Operational Agreement is at-will and may be modified by mutual consent of authorized officials from RARCC or AUSD.
