c. Ward 6 Update

Minutes:

Councilmember, Mr. Jim Perry shared information regarding a new program the City of Riverside is implementing, which is a park and neighborhood services program. Mr. Perry stated that twenty park rangers would be hired and assigned to parks throughout the city. The park rangers' main responsibility will be to address safety issues at their assigned parks and neighborhoods. Mr. Perry shared that the park rangers will be riding electric bikes. Mr. Perry stated the City of Riverside is currently going through the budget process and the city is seeking to expand the Public Safety and Engagement Team Program, to ensure safety in the community. Mr. Perry also shared that a Youth Visioning Day event would be taking place on Saturday, April 30, 2022 at the Riverside Northgate-Gonzalez Market. This event is in partnership with Councilmember, Mr. Jim Perry and Northgate-Gonzalez Market. This event will provide Riverside City Youth Council and Alvord USD students an opportunity to provide input on how they view their neighborhoods and how they would like to envision their community in the future. Mr. Perry stated that Northgate-Gonzalez Market owner, Don Miguel Gonzalez will be speaking to the students regarding entrepreneurship.
