WHEREAS, pursuant to Education Code section 44954(b), the Board may release a substitute and/or temporary certificated employee if the employee is notified before the end of the school year of the District's decision not to reelect the employee for the next succeeding school year; and

WHEREAS, the following temporary employees have been employed by this District in position requiring certification qualifications:

WHEREAS, it is this Board's intent to release and not reelect the above referenced employees for the 2022-2023 school year, pursuant to Education Code section 44954(b); and

WHEREAS, the decision to release and non-reelect the above named employee is made on an individualized basis.

NOW, THEREFORE, BE IT RESOLVED, as follows:

1. That the Board has determined that it is necessary at this time to send notice to the individual employee indicated above that they are being released from their position and will not be reelected for the subsequent school year for the reason set forth above, and as further supported by documents possessed by the District; and

California Education Code

44954. Governing boards of school districts may release temporary employees requiring certification qualifications under the following circumstances:

(a) At the pleasure of the board prior to serving during one school year at least 75 percent of the number of days the regular schools of the district are maintained.

(b) After serving during one school year the number of days set forth in subdivision (a), if the employee is notified before the end of the school year of the district's decision not to reelect the employee for the next succeeding year.
