



Dear Wade,

The purpose of this letter is to record an adjustment to the Basic Services Fee for the New Central Kitchen project for NVUSD. The original Basic Services Fee of \$257,500 was based on a Construction Estimate of \$2,300,000. The recent bid award to was recorded at \$4,541,779, which generates a new Basic Services Fee of \$481,678, an increase of \$224,178. When added to the current total project fee, including previously approved supplemental service consultant fees, of \$286,880, the new total project fee is \$511,058.

The new total fee will be reflected on our August services billing, which will be processed at the beginning of September. I trust that your records agree with ours but, should you have any questions or concerns, please let me know before the end of August so that we can address any issues before the next billing cycle.
