11. REPORTS FROM MEMBERS OF THE BOARD AND SUPERINTENDENT

Minutes:

Board Member Chuck Coyne thanked community members for passing the bond measures that allowed for modernization over the past 15 years. He thanked Bonita High School for the use of their school for Board meetings over the past two years. He thanked staff members for their hard working in preparing the LCAP. He reported attending the graduations and promotions saying they are always emotional. He toured the Career Technical Education classes at the Fairplex, and he attended a McKinley Children's Center Board meeting.

Mr. Coyne was also able to attend a few open house events, judge senior projects, and saw the opening of the La Verne Heights time capsule.

Board Member Matthew Lyons said he completed his first full year as a School Board Member, and he participated in his second cycle of promotions. It is a highlight to be part of a student's culmination of their educational experience. He gave congratulations to all the graduates.

Mr. Lyons recognized the excellence of the teachers, staff, and students. He reported an additional highlight was the La Verne Heights Multicultural Festival; a wonderful community and multi-generational event. Mr. Lyons encouraged administrators to continue to send invitations to Board members to attend special site events. He attended the La Verne-San Dimas Perseverance Awards Ceremony and mentioned it was great to see students be recognized.

Board Member Lyons gave an update of the full and fair funding initiative and reported that California is the fifth largest economy in the world, but ranks 45th in funding the student-teacher ratio. He encouraged everyone to add a voice and sign an online petition to increase funding for public education. He provided the website address.

Board Member Glenn Creiman attended the Teachers of the Year events, Perseverance Awards Ceremony, and open house events at schools. He thanked the community for passing the bond measures. He reminded everyone that it was a conscience decision that modernization of the District office was the last on the bond list. The Board wanted the schools to be first to receive upgrades. The budget was slightly under showing that the District has been good stewards of the money. Mr. Creiman reported he job shadowed at Ramona Middle School. While at Ramona, the person he shadowed handles all the pest control in the district. He witnessed the

blocking out of skunks, and the handling of a bee infestation. He learned how the District ensures the safe use of pesticides. The District purchases pesticides from an approved list to make sure they are safe for kids.

Mr. Creiman reported he is looking forward to the evening's recognition of a CIF Champion.

Board Member Diane Koach reported she enjoyed the dance festival at La Verne Heights. Each grade celebrated a different country with a dance. It was a fun event for the whole family and she acknowledged the amount of work teachers do. The Festival provides special memories for the kids. She attended graduations and promotions. They are touching and heartwarming for parents. She especially enjoyed seeing the expressions on the graduates' faces when they realized they did it. She welcomed District office staff back to San Dimas in an updated office, and she thanked those involved in making it happen. She wished a nice summer.

Superintendent Carl Coles reported that a single purpose unites the District, to prepare every student so they can live their purpose. He enjoyed the experience of shaking the hands of over 1,000 students who graduated. When goodbyes are said, there is an overwhelming sense of gratitude towards the 1,100 employees and the five Board members who work hard to support the 10,000 kids. A new wave of kindergartners are coming in, and we begin all over again, but with the same purpose.

12.1. Recognition of Bonita Unified School District Top Readers - Introduced by Matthew Wien

Minutes:

Assistant Superintendent Matthew Wien reported that it is a main area of focus to ensure students are reading at grade level. He introduced Sr. Director Chris Ann Horsley who was joined by Sr. Director Anne Neal, and together they presented the District's top readers with certificates of recognition.

12.2. Recognition of Bonita High School Student Athlete Alisha Wilson Who Won CIF-SS Division 2 Championship Title - Introduced by Kevin Lee

Minutes:

Assistant Superintendent Kevin Lee introduced Principal Kenneth Ritchie who gave an overview of the success of Bonita High School student-athlete Alisha Wilson. Mr. Ritchie said that Miss Wilson is a tremendous athlete who competes in many different sports. Last year, she was a member of relay team that won a CIF title. Tonight, the District is recognizing her for her CIF Division 2 title in the 400 meters. Mr. Ritchie presented Miss Wilson with a certificate of recognition.

12.3. Recognition of the District Classified, Certificated and Management Employees of the Year - Introduced by Kevin Lee

Assistant Superintendent Kevin Lee introduced Classified Employee of the Year,

Vivian Randall, and Management Employee of the Year, Chris Black. He read a brief acknowledgement of their accomplishments. Board President Diane Koach and Superintendent Carl Coles presented them with plaques to thank them and recognize them. Certificated Employee of the Year, Deborah Brownlee was not in attendance.

12.4. Presentation on Short-Term Residential Treatment Programs (STRTP) and Bonita Unified School District Foster Youth Population

Minutes:

Mr. Matthew Wien introduced Sr. Director Mark Rodgers who presented information related to foster youth and the Short-Term Residential Treatment Programs (STRTP). His presentation included a background of AB 403, Foster Youth: Continuum of Care Reform, and the phasing out of foster group homes. Group homes are being replaced by private or foster homes. Mr. Rodgers reported that the process did not address therapeutic needs of the students in the educational system and the intensive therapeutic environment needed.

He reported that students who are in the STRTP spend barely a quarter of the school year with Bonita Unified. Often, foster students come with significant educational gaps in credits. Chaparral High School has students who refuse to attend school. Student move so frequently they do not an IEP to support them. Bonita Unified spent a lot of time building systems to support students in foster care. The new funding models do not account for students in STRTP. The funding models do not match the needs. Bonita Unified needs to bolster support for these students.

12.5. Presentation on College and Career Readiness Opportunities - Introduced by Matt Wien

Minutes:

Mr. Matthew Wien reported that Bonita Unified District offers strong, robust academic programs. The District will look at the next phase by taking a serious look at college and career readiness opportunities by planning for the long-term, the short-term, and creating a framework.

Mr. Wien introduced Sr. Director Anne Neal who gave a presentation that included the opportunities of Career Technical Education (CTE), District partnerships, CTE pathways, Dual Enrollment, articulated courses, and the next steps.

Mrs. Neal answered questions from the Board, and Mr. Coyne requested a list of CTE sectors.

Mrs. Susan Cross Hume, Assistant Superintendent-Business Services, provided information to the Board about the Education Protection Plan (EPA). The EPA was initiated in 2012 from Prop 30. The funds are not additional

funds, but rather the state uses the EPA to offset LCAP funding. Each year, Districts are required to report how they spend money. Mrs. Hume reported that Bonita Unified uses the EPA money on teacher salaries.
