Language in Proposition 39 requires that the following groups be represented on the Oversight Committee:

- One member active in a business organization located within the district;
- One member active in a Senior Citizens' Organization;
- One member who is the parent or guardian of a child enrolled in the district;
- One member who is both a parent/guardian of a child enrolled in the district and active in a parent-teacher organization or school booster organization;
- One member active in a bona fide taxpayers' organization; and
- No district employee, official, vendor, contractor or consultant may service on the committee.

Beyond this requirement, the Board of Education has been determined that up to 11 additional individuals will be asked to serve. Frequency of meetings will be up to the assembled oversight committee, but will probably be conducted at least every other month. The Board has also agreed to provide funding to the Oversight Committee for independent audits or other projects deemed appropriate by the Committee.


