Dear Jeff:

As you know, by not accepting the Alternate Bid at the time of the Building A Modernization bid package, BHUSD effectively de-scoped the re-roofing of the mission tile from the construction project. WLC understands that BHUSD is now interested in re-bidding, awarding, and installing new roofing materials. This additional design effort would be considered an additional service under WLC's Owner/Architect Agreement.

I have outlined the Scope, Schedule, and Design Fee Structure below:

Scope of Work:

WLC will prepare design contract documents showing the removal and replacement of all of Building A's clay tile roofing, and the repair and replacement of any damaged or deteriorated building felts, plywood, flashings, gutters, and downspouts. The drawings will also cover the removal/replacement of a limited number of built-up roofing areas.

Since the re-roofing was included in the original DSA-approved Modernization Package (A 03-115072) WLC assumes that the above described design scope will not require a new DSA submission. However, all new drawings, specifications, details and/or calculations will need to be submitted and approved through DSA's post-approval CCD procedures.

WLC assumes that the work will not require any engineering consultants (structural, mechanical, electrical, plumbing).

Project Schedule:

WLC understands that BHUSD would like to design, publicly bid, and award the project so that construction can take place over summer break 2019.

WLC proposes to provide the services outlined above, to the schedule described above, for the fee as outlined below and to a percentage of completion per phase, per month.


Construction Documents:	\$32,000.00	Fixed Fee
