RESOLUTION 2019-10

**REGARDING RELEASE OF EMPLOYEES SERVING IN CERTIFICATED
POSITIONS PURSUANT TO TEMPORARY OR CATEGORICAL
CONTRACTS AND/OR PURSUANT TO AND POSSESSING ONLY
EMERGENCY PERMITS OR PRE-INTERN TEACHING CERTIFICATES**

WHEREAS, the District currently employs various persons serving in certificated positions pursuant to temporary or categorical employment contracts and/or as employees serving solely pursuant to and possessing only short term staff permits, or as employees serving solely pursuant to and possessing only a pre-intern teaching certificate;

WHEREAS, the time served by employees serving in certificated staffing positions pursuant to, and possessing only short term staff permits or pre-intern teaching certificates, cannot be included in computing the service required as a prerequisite and attainment of or eligibility to classification as a permanent employee, and such employees therefore are non-probationary and non-permanent employees pursuant to Education Code Section 44911 and judicial and administrative interpretations;

WHEREAS, some employees' temporary or categorical contracts indicate an expiration date of June 30, 2019 at the latest;

WHEREAS, Education Code Section 44954 requires the Governing Board to notify certain temporary employees before the end of the school year of the District's decision to not reelect the employee for the next succeeding school year;

WHEREAS, as this Board of Trustees reviews the educational priorities of this District in the context of implementing the delivery of kindergarten through twelfth grade educational services, and determines the number and kinds of personnel necessary for the effective operation of this District, this Board intends to decrease, where possible, reliance upon employees serving in classroom teaching positions pursuant to and possessing only pre-intern teaching certificates, short term staff permits and/or as temporary employees;

NOW, THEREFORE, BE IT RESOLVED AND ORDERED, that the following individuals serving pursuant to temporary or categorical contracts and/or serving pursuant solely to and possessing only short term staff permits or pre-intern teaching credentials be and are not reemployed for the next succeeding school year and are released from employment with the Bonita Unified School District effective upon the last day of this current school year or their temporary contract, whichever occurs first:
